## C201/17 To receive a report from the Needham Market Neighbourhood Plan Working Group.

Cllr Norris reported an inception meeting has been arranged to take place on Friday 17<sup>th</sup> November, with representatives from the Government's Planning Agent AECOM, in respect of the viability/feasibility study on possible development beyond the existing southern boundary of the town. He added what the objectives will be for the meeting.

Cllr R Campbell referred to the time which has elapsed since the Draft Needham Market Neighbourhood Plan was produced and questioned whether its content remained relevant. Cllr Stansfield said this is one of the concerns the Planning Agents from AECOM would be able to advise on.

Cllr R Campbell commented the establishment of a newly defined development boundary would accelerate development. Cllr Stansfield explained why the Planning Agents from AECOM had been called in to help with consideration of establishing a new development boundary. Cllr R Campbell added his comment did not mean he wishes or suggests development is held back but, the establishment of a new development boundary will make development inevitable.

## <u>C202/17 To receive a report from the Annual General Meeting of the Suffolk Association of Local Councils held 7th November.</u>

Cllr Lea said she had not been able to attend the Annual General Meeting however papers from the meeting will be available in due course.

Cllr Lea added, in advance of the AGM, information had been requested from local councils regarding their experience with Neighbourhood Planning. Relevant information had been provided setting out the Town Council's position.

Cllr Carter reported the campaign petition has attracted 1,000 signatories.

Cllr Carter referred to a (current draft) letter which Suffolk County Council intended to send to the Secretary of State for Transport which promoted allocation of funds to resolve the access issues at Needham Market Railway Station. Each Councillor had been provided with a copy of the (current draft) letter.

Cllr Carter proposed the Town Council countersign the (final) letter, at the same time indicating the letter could make a more forceful case for the need for access at Needham Market Railway Station to be improved. Cllr Ward seconded the proposal. Council agreed the proposal.
