<u>MINUTES</u> of the meeting of NEEDHAM MARKET TOWN COUNCIL held in the Green Room, Needham Market Community Centre, School Street, Needham Market, on Wednesday 19th October 2016 at 7:30pm.

C194/16 To confirm the Minutes of the Town Council Meeting held 5th October 2016.

The Minutes of the Town Council Meeting held Wednesday 5th October 2016 were accepted as a true and correct record and signed by the Chairman.

C195/16 To receive Councillors' Declarations of Interest for Matters on the Agenda.

<u>C196/16 To receive reports from The County Councillor, District Councillors and, to take guestions from members of the public.</u>

County Councillor Julia Truelove presented her report, which was tabled and a copy of which will be appended to the Minute Book. It included reference to:

- Devolution Scrutiny Committee 'Recommendations to Cabinet' examples from among those for consideration including; an estimate of paid officer time put into devolution work, the cost of devolution in Suffolk and clarity as to the circumstances in which an elected mayor would have power to over-rule majority decisions of the Combined Authority
- Broadband Provision superfast broadband rollout has reached another 10,000 Suffolk homes and businesses
- Flood Alleviation Proposals following the meeting of the Local Flood Working Group held on 5th October, it is suggested the Town Council invite the Environment Agency and Suffolk County Council to a Town Council meeting

Cllr Phillips said he had procured a home broadband service from BT which included a £50 connection fee and, on switching to another broadband provider, had again to pay a £50 connection fee.

Cllr Phillips proposed Council adopt the suggestion regarding calling the Environment Agency and Suffolk County Council to a meeting with the Town Council regarding progress on flood alleviation. Council agreed the proposal.

District Councillor Wendy Marchant presented the District Councillors report, which was tabled and a copy of which will be appended to the Minute Book. It included reference to:

- Proposed New Scout Hut for Needham Market Needham Market Scout Group is investigating the possibility of building a new Scout Hut on the site of the existing one at the Camping Land
- Flood Risk in Needham Market various options raised at the 5th October meeting to help prevent future flooding in the Crown Street area
- Annual Meeting of Suffolk Historic Churches Trust the Trust no longer receives grant aid from Mid Suffolk District Council
- Planning Application for Extension of the Rampant Horse Public House whilst in favour of businesses expanding our District Councillors are concerned about impact on neighbouring residential property.

District Councillor Mike Norris added an update on the Planning Application for Extension of the Rampant Horse Public House. The applicant is, in view of the concerns regarding the impact on neighbouring residential property, prepared to make various changes to the original planning proposal. The immediate residential neighbour was said to have agreed, on balance, with those changes. The District Council's Planning Committee had reconvened and resolved to authorise the Lead Planning Officer to decide on the application following a further 21-day consultation period.

Cllr M Spurling said he was keen to see the revised planning proposals for the extension of the Rampant Horse Public House.

Cllr Lea suggested the Town Council should discuss the proposals further with the neighbouring residents. Cllr M Spurling confirmed the neighbours had been spoken with and they have been invited, if they so wish, to attend a future Town Council meeting.

Cllr Phillips, referring to the proposal for a new Scout Hut, confirmed the Town Council has always supported the scout group's ambition to replace its existing poor accommodation and suggested Councillors may wish to meet with the representative from the scout group who is leading the proposal. Cllr Stansfield said he felt the existing scout hut location remains appropriate for redevelopment for continued use as it offers immediate access to the open spaces afforded by the Camping Land and Needham Lake.

The member of public present had no question to raise.

Cllr Lea said the Town Council had objected to the proposed removal of the pay-phone, Barking Road on a previous occasion but, as the accompanying information showed it has only been used twice in the past 12 months there are no longer grounds for objecting to its removal.
